Request Committee to recommend to the Board to award bid to the lowest responsible and responsive bidder, for Lawn Maintenance at the BWW Main Campus, contingent upon staff's evaluation and review by the Board's legal counsel; and to authorize the General Manager and/or Assistant General Manager to execute applicable documentation.
- 3. Request Committee to recommend to the Board to approve a purchase with Interior Elements, for cubicles for the System Development Department, at an out-of-pocket cost of \$135,807.90; and to authorize the General Manager and/or Assistant General Manager to execute applicable documentation.
