Prospective Bidders:

We will be pleased to receive a proposal from you for materials set forth on the enclosed bid sheets. These bids must be submitted in duplicate on the forms provided by the "Board" for that purpose. Sealed bids for Pipe and Fittings (Annual) will be received in the Purchasing Department no later than **10:00 a.m., Friday, October 4, 2024**, at which time and place they will be publicly opened and read.

You are invited to quote unit prices in your proposal to furnish "**our requirements**" for the period *approximately* from **February 1, 2025**, through **January 31, 2026**, (*depending upon the award of bid date*) and all prices quoted shall be **FIRM**. The term "*our requirements*" shall be interpreted to mean all orders placed not necessarily shipped, during the contract period. **The Board reserves the right to exercise its option to extend the contract for up to two (2) additional years, with the mutual consent of both parties. The Board will also have the option of canceling this contract in thirty (30) days with written notice, the Board has the right to rebid, the Board also has the right to go month-to-month with the mutual consent of both parties.**

Estimated quantities furnished should cover our needs if business will approximate its present level. These quantities are, however, furnished as a guide only and are not to be considered as firm commitments. Estimated quantities for *4" through 60" Zinc-Coated* pipe represent "Slip Joint" requirements only (and "Restrained Joint", where noted). Estimated quantities of fittings represent "Mechanical Joint" only. *The "Board" reserves the right to increase or decrease quantities and will not be bound to purchase any certain amount of any material. BWWB reserves the right to order items not listed in this "Pipe Bid" from the vendor awarded the contract.*



The Birmingham Water Works Board requires that only pipe manufacturers may submit proposals for BWWB “Pipe Bid” and the pipe manufacturers who submit a bid must supply the pipe, V-Bio enhanced polyethylene encasement, mechanical joint fittings and accessories quoted in their respective bid. BWWB requires the ability to direct all their questions regarding parts, delivery and product concerns that arise after bid award to the bidder who is awarded the “Pipe Bid”. The approved vendors for BWWB are ACIPCO, McWane and U.S. Pipe. If a vendor must purchase the pipe that he is unable to provide, he can only purchase the pipe from the approved BWWB vendors. **If purchased elsewhere, his bid will be rejected.**

Unit prices quoted for our annual “*Pipe, V-Bio enhanced Polyethylene Wrap, and Mechanical Joint Fittings*” shall be FOB *any carrier designated by the “Board” at foundries* in the City of Birmingham and its environs. *Pipe, V-Bio enhanced Polyethylene Wrap, and Mechanical Joint Fittings* shall be available within a reasonable time after the order for materials has been placed. Orders will be submitted to the foundry as the need arises and after pipeline construction is committed.

BWWB Pipeline Contractors will haul pipe and polyethylene wrap from the pipe foundry or local distribution yard. Per certain orders, however, BWWB will request pipe manufacturer to deliver pipe and V-Bio enhanced polyethylene wrap from foundry to BWWB warehouse.

Unit prices quoted for fittings shall be “FOB” destination at BWWB Warehouse. Vendor shall maintain a minimum stock level of 1000 lineal feet in each of the 4”, 6”, 8” and 12” sizes of pipe. BWWB reserves the right to request pipe manufacturers submit pipe installation drawings.

The manufacturer will furnish a sworn statement that the inspection and all specified tests have been made and all results thereof comply with the requirements of ANSI/AWWA Standards.

The entire process of the manufacturer of items to be furnished shall be open always to the inspection of The Birmingham Water Works Board Engineer or designated representative. The manufacturer shall allow the Water Works Board's inspector and/or pipeline contractor access to those areas of the plant or local distribution yard so he can at such times he or the Board deems necessary, view and inspect pipe stock, witness the tests and also take samples for testing in his laboratory. Approval at time of plant inspection shall not prevent rejection if defects are subsequently discovered.

Only one contract will be awarded, and it will be made to the lowest responsive and responsible bidder on both pipe, wrap and fittings. All items listed in “Pipe Bid” must be quoted and supplied by the vendor. Not quoting an item will result in the bid being rejected.

The right is reserved to reject any or all bids submitted, to waive any informalities and technicalities and to award the contract in the best interest of the "Board."

SPECIFICATIONS AND CONDITIONS FOR MECHANICAL JOINT FITTINGS & ACCESSORIES

September 23, 2024

The standard mechanical joint fittings shall be cement lined, paint seal coated inside, asphaltic coated outside, and complete with all accessories unassembled. Sizes 24” and smaller are to be **Compact C-153 Class 350 Ductile Iron** with ductile iron follower rings (glands). Sizes 30” and larger are to be **C-110 Class 250 Ductile Iron** with ductile iron follower rings (glands). Fittings are to be bell unless otherwise specified. Cement lining and paint seal coating to be in accordance with ANSI/AWWA C104-A21.4-08 with standard coating outside. Also acceptable are ductile iron fittings coated with a 6-8 mil nominal thickness fusion bonded epoxy conforming to the requirements of ANSI/AWWA C550 and C116/A21.16. The fittings in this bid shall include ells and bends all bell only, tees and crosses all bell only, solid sleeves long pattern, reducers all bell and small bell concentric, plugs and caps. The net ton prices shall include the necessary Ductile Iron Mechanical Joint accessories for all sizes, manufactured in accordance with ANSI/AWWA Standards C111/A21.11-07. The bolts and nuts are to be of alloy cast iron (such as Acipcoloy) or Alloy Steel (Corten type such as U.S. Alloy) or approved equal.

Unit prices quoted must be F.O.B. destination, which is our Warehouse, located at 3505 Messer Airport Highway, deliver through entrance at 3500 Second Avenue North, Birmingham, Alabama 35222. Delivery of fittings and accessories shall be made within a reasonable time after the order for materials has been placed.

**If bidding on a product manufactured by another firm, you must submit a letter from the manufacturer of that product giving your company as agent authority in Birmingham, Alabama to bid that product.

Letter may be a blanket letter from manufacturer renewable at the beginning of the calendar year giving your company authorization to bid on and sell the products that you are quoting. This letter may cover as many items as are represented by your company.

BWVB requires the ability to direct all their questions regarding parts, delivery and product concerns that arise after bid award to the bidder who is awarded the “Pipe Bid”.



AMERICAN IRON & STEEL (AIS):

All iron and steel products in this specification must comply with American Iron and Steel (AIS) requirements. The requirements were established in the 2014 Consolidated Appropriations Act (CAA) under Section 436 (Public Law 113-76) which was made permanent in 2014 by the Water Resources Reform and Development Act amending the Clean Water Act under Section 608 for all Clean Water State Revolving Fund (CWSRF) loan recipients. The Water Infrastructure Finance and Innovation Act of 2014 (WIFIA Program) administered by the U.S. Environmental Protection Agency (EPA) mirrors the Clean Water and Drinking Water State Revolving Fund programs (refer to Statute 33 U.S.C. §3914) as it relates to AIS requirements.

MANUFACTURER AIS CERTIFICATION LETTER:

Products made primarily of iron or steel (greater than 50% iron or steel, measured by material cost only) must be produced in the United States. Product manufacturer must certify products and/or materials provided by manufacturer are in full compliance with the American Iron and Steel (AIS) requirement as mandated in the Environmental Protection Agency's State Revolving Fund Programs. The Water Works Board of the City of Birmingham (Water Board) shall request and obtain AIS Certification Letters from iron and steel manufacturer supplying products and/or materials to the Water Board to be incorporated into projects.

In case of default by the vendor, the Board may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the vendor, the difference between the price named in the contract or purchase order and the actual cost thereof to the Board. Prices paid by the Board shall be considered the prevailing market price at the time such purchase is made.

Standard Mechanical Joint Fittings shall be cement lined, paint sealed coated inside, asphaltic coated outside, or epoxy coated.

All fittings must be complete with all accessories unassembled.

Sizes **24" and Smaller are to be Compact C153 Class 350** Ductile Iron with Ductile Iron Follower Rings (glands) – with the following exceptions – **Plugs and Caps 12" and smaller are to be C110 Full Body.**

Size **30" and Larger are to be C-110 Class 250** Ductile Iron with Ductile Iron Follower Rings (glands).

Fittings are to be all bell unless otherwise specified.

1. Reducers are to be **CONCENTRIC** design.
2. Sleeves must be **LONG** pattern.

1. The following prices shall be for furnishing Ductile Iron "Slip Joint" pipe (and Class 350 "Restrained Joint", where noted) manufactured in accordance with ANSI/AWWA Standard C151/A21.51-09, Grade 60-42-10 Iron, having a minimum tensile strength of 60,000 P.S.I., minimum yield strength of 42,000 P.S.I., and minimum elongation of 10%. Pipe is to be asphaltic coated outside in accordance with ANSI/AWWA Standard C151/A21.51-09, cement lined inside (1/16" minimum thickness) and paint seal coated in accordance with ANSI/AWWA Standard C104/A21.4-08.

The exterior of ductile iron pipe shall be coated with a layer of arc-sprayed zinc per ISO 8179. The mass of the zinc applied shall be 200 g/m² of pipe surface area. A finishing layer topcoat shall be applied to the zinc. The mean dry film thickness of the finishing layer shall not be less than 3 mils with a local minimum not less than 2 mils. The coating system shall conform in every respect to ISO 8179-1 "Ductile iron pipes- External zinc-based coating - Part 1: Metallic zinc with finishing layer. Second edition 2004-06-01." All piping must be clearly marked on the exterior of the Zinc-Coated pipe with the wording "ZINC" at the center of the pipe and with identifying markings at both ends of the pipe.

Manufacturer shall provide the BWWB with the Foundry's compliance with NSF/ANSI 61 Standard for each lot/shipment of materials.

Manufacturer shall provide the BWWB with each lot/shipment of pipe written transcripts of the Foundry Records per Section 5.4 of the Standard including Hydrostatic tests of each pipe, Tensile tests, Charpy impact tests and additional low temperature Charpy impact tests as required by Section 5.2 and 5.3 of the Standard. Additionally, per Section 5.1.1.2 of the Standard the Manufacturer shall provide a sworn statement that the inspections and specified tests of Section 5 of the Standard have been made and the results thereof comply with the Standard.

Per Section 6.2 of the Standard, the Manufacturer shall provide the BWWB with each shipment/lot of pipes an Affidavit of Compliance that the material provided complies with the applicable requirements of the Standard.

Prices shall be based upon furnishing Tyton, Bell Tite, Fast Tite or Altite and the gaskets shall be single rubber type employing a groove feature in order to assure a positive lock in place against displacement. The unit price shall include rubber gaskets and lubricants of the type and in quantities recommended by the pipe manufacturer.

The Pressure Class, net weight of pipe without lining, length of pipe and name of manufacturer shall be clearly marked on each length of pipe.

Provide V- Bio Enhanced polyethylene encasement in complete accordance with ANSI/AWWA C105/A21.5, Standard for Polyethylene Encasement for Ductile Iron Pipe Systems, of latest revision.

Polyethylene tube shall be linear low-density film, 8-mil minimum thickness, white in color, new and manufactured of virgin polyethylene material. The inside surface of the polyethylene wrap to be in contact with the pipe exterior shall be infused with a blend of anti-microbial biocide to mitigate microbiologically influenced corrosion and a volatile corrosion inhibitor to control galvanic corrosion. Provide sufficient quantity of 1-1/2" wide adhesive tape as required to properly install Polyethylene encasement per the Standard.

THE WATER WORKS BOARD OF THE CITY OF BIRMINGHAM HISTORICALLY UNDERUTILIZED BUSINESS (HUB)

General Mission Statement

The Water Works Board of the City of Birmingham ("BWWB") has adopted a voluntary Historically Underutilized Business ("HUB") Program designed to encourage the participation of HUB firms in construction projects and goods and services. To that end, the BWWB will not exclude any firm from participation in, deny any person benefits of, or otherwise discriminate in connection with the award and performance of BWWB construction contracts and goods and services bids based on racial gender social or economic status.

It is the intent of the BWWB to foster competition among contractors, suppliers, and vendors that will result in better quality and more economical services for the BWWB. Under this program, the BWWB has established a goal of 30% participation of HUB firms for services required for BWWB construction projects goods and services. The BWWB's stated goal will not be the determining factor in construction and goods and services contract awards; rather bidders must demonstrate compliance with the Good Faith Efforts, more particularly outlined below, toward meeting said goal.

Failure on the part of a bidder to fully submit the information required herein may be considered by the BWWB in evaluating whether the bidder is responsive to bid requirements.

NOTE: If Bidder is a direct manufacturer/direct supplier of the goods or services sought in this Bid and has no opportunities for HUB participation, Bidder should fill out the Direct Manufacturer/Supplier Certification Form 6.

Program Goals

- To ensure nondiscrimination in the award and administration of BWWB construction contracts and goods and services.
- To help to remove barriers to the participation of HUB firms in receiving BWWB construction contracts and bids for goods and services.
- To create a level playing field on which HUB firms can compete fairly for BWWB construction contracts and bids for goods and services.

Definitions

1. Historically Underutilized Business (HUB): A business formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by one or more American citizens or permanent resident aliens who are: Minority Business Enterprise (MBE); Women's Business Enterprise (WBE); Disadvantaged Business Enterprise (DBE) and Disable Veteran Business Enterprise (DVBE); (herein sometimes collectively referred to as HUB).
2. Minority Business Enterprise (MBE): A business that is formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by a person who is a member of the following groups: African/Black Americans; Hispanic Americans; Asian Pacific Americans; Subcontinent Asian Americans; Native Americans or American Women.

3. **Disadvantaged Business Enterprise (DBE):** A business that is formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by one or more socially and/or economically disadvantaged individuals. A socially disadvantaged individual is one who has been a subject of racial, ethnic or gender bias because of their membership in a group. An economically disadvantaged individual is one whose ability to compete in the free enterprise system is impaired due to diminished opportunities to obtain capital and credit.
4. **Women's Business Enterprise (WBE):** A business enterprise formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by American citizens or permanent resident aliens who are women.

Affirmative Steps for Good Faith Solicitation

All bidders must submit to BWWB in their sealed bids evidence of the following Affirmative Steps taken to utilize HUB's. These Affirmative Steps are required methods to ensure that HUB's have the opportunity to compete for contracts with BWWB.

It is up to BWWB to make a fair and reasonable judgement whether a bidder/prime company made adequate good faith efforts. The BWWB will consider the quality, quantity, and intensity of the different kinds of efforts that the bidder/prime company made. The efforts employed by the bidder/prime company should be those that one could reasonably expect a bidder/prime company to take if the bidder/prime company were actively and aggressively trying to obtain HUB participation sufficient to meet the HUB Program goals.

Below is a list of types of steps that BWWB will consider as part of the bidder's/prime company's good faith efforts to obtain HUB participation. It is not intended to be a mandatory checklist, nor is it intended to be exclusive or exhaustive. Other factors or types of efforts may be relevant in appropriate cases:

1. Ensure HUBs are made aware of contracting opportunities to the fullest extent practicable through outreach and recruitment activities. Soliciting through all reasonable and available means (e.g., attendance at pre-bid meetings, advertising, and written notices) the interest of all certified HUB's who have the capability to perform the work of the contract. The bidder/prime company must solicit this interest within sufficient time to allow the HUBs to respond to the solicitation. The bidder/prime company must determine with certainty if the HUBs are interested by taking appropriate steps to follow up initial solicitations.
2. Make information on forthcoming opportunities available to HUB's and arrange time frames for the submission and finalization of contracts and established delivery schedules, where the requirements permit, in a way that encourages and facilitates participation by HUB businesses in the competitive process. This includes, at a minimum, seeking and receiving solicitations for contract bids or proposals 2 calendar days before sealed bids are due to BWWB.
3. Once the contract has been awarded, the prime company should continue to use its best efforts to further increase HUB participation toward reaching the BWWB stated goal.
4. Consider in the bidding process when competing for large contracts the possibility of dividing total requirements whenever economically feasible into smaller tasks or quantities to permit maximum participation by HUBs in the competitive process.

5. Encourage contracting with a consortium of HUB's when a contract is too large for one such firm to handle individually.
6. Negotiate in good faith with interested HUB sub-companies. Evidence of such good faith negotiations should include the names, addresses, and telephone numbers of HUB sub-companies that were considered; a description of the information provided regarding the request for proposal, request for qualifications, plans and specifications for the work selected for contracting; and evidence as to why additional agreements could not be reached for HUB sub-companies to perform the work.
7. Provide documented proof of steps taken to comply with items 1 through 7 above.

Bidders/Prime companies must submit or provide the following HUB Forms as outlined below:

- 1) **Acknowledgement of HUB Program (HUB Form 1)**. All bidders are to read, sign and include in their sealed bid the Acknowledgement of HUB Program, indicating that they fully understand and will voluntarily participate in and follow the guidelines and instructions included in the BWB HUB Program.
- 2) **HUB Compliance Form (HUB Form 2)**. This form must be completed and included with all sealed bids for goods and services/public works with the BWB.
- 3) **HUB BID SOLICITATION NOTICE {HUB FORM 3}**. All bidders shall complete this form and submit to the BWB and the HUB Consultant no later than seven (7) days after the scheduled date of the pre-bid conference. This form may be submitted in person at the pre-bid conference. Prospective bidders are to submit with their bid documents a copy of their HUB Form 3 with acknowledgement of receipt box completed by the HUB Consultant. (This form has been removed)
- 4) **HUB Sub-company Participation Form (HUB Form 4)**. This form gives a HUB sub-company the opportunity to describe the work the HUB sub-company received from the bidder/prime company, how much the HUB sub-company was paid, and any other concerns the HUB sub-company might have. Bidder/prime company shall provide copies of HUB Form 4 to all HUB sub-companies.
- 5) **HUB Sub-company Performance Form (HUB Form 5)**. This form captures an intended HUB sub-company's description of work to be performed for the bidder and the price of the work proposed to be performed by the HUB sub-company. This form is to be provided by the bidder to each HUB sub-company and submitted along with the HUB Compliance Form included in the bid documents.
- 6) **HUB Direct Manufacturer/Supplier Certification (HUB Form 6)**. This form captures the direct manufacturers or suppliers of goods and services sought in the bid and have no distributors, wholesalers, retailers, or other intermediaries, and thus do not have any opportunities for HUB participation in this Bid. **(This form is used for Goods and Services bids only)**

7) **HUB Sub-company Utilization Form (HUB Form 6)**. This form captures the bidder's/prime company's intended use of an identified HUB sub-company and the estimated dollar amount of the work. This form is to be completed by the bidder/prime company and submitted with the HUB Compliance Form included in the bid documents.

(This form is used for Public Works bids only)

8) **Changes to Approved HUB Compliance Form (HUB Form 7)**. If any changes, substitutions, or additions are proposed to the sub-company identified in the bid or any other time during the work, the bidder/prime company must submit this information to BWWB for prior written approval. No changes to the sub-company can occur without the BWWB's prior written consent.

(This form is used for Public Works bids only)

9) **Monthly Report Form (HUB Form 8)**. With each monthly pay request submitted to BWWB, the prime company is required to submit updated monthly **HUB Form 8** reports which identify HUB firms' participation. Monthly pay requests **will not be processed** without the updated list of HUB firms.

(This form is used for Public Works bids only)

10) **Project Close-out Report (HUB Form 9)**. Upon completion of the contract and prior to final payment or release of retainage, the prime company is required to submit a **HUB Form 9** Project Close- Out Report that includes a final listing of all HUB participants on the project. The Project Close-Out Report, with documented HUB participation, is a prerequisite to process the final pay request.

(This form is used for Public Works bids only)

Sub-companies must be certified as HUBs in order to be counted toward the bidder's/prime company's HUB accomplishments.

The documentation of the good faith solicitation efforts must be detailed in order to allow for satisfactory review. Such documentation might include fax confirmation sheets, copies of solicitation letters/emails, printouts of the online solicitations, printouts of online search results, affidavits of publication in newspapers, etc. The bidder/prime company is strongly encouraged to follow up on each written, fax, or email solicitation with at least one logged phone call.

The bidder/prime company must employ the affirmative steps set out above to subcontract with HUB, even if the bidder/prime company has met its goal of HUB participation.

If a HUB sub-company fails to complete work under the subcontract for any reason, the prime company must notify BWWB in writing prior to any termination and must employ the good faith efforts described above if using a replacement sub-company. Any proposed changes from an approved HUB sub-company must be reported to BWWB on the Changes to Approved HUB Compliance Form (**HUB Form 7**) prior to initiation of the action.
